REGULATION OF THE CREATIVITY CONTEST

PREAMBLE

Since its creation, SIAO, has distinguished itself as the ideal setting for African craftsmen to make themselves known to the general public and especially to professional buyers who come from diverse backgrounds.

At each edition of SIAO, authorities and various partners put into competition prizes to recognize and magnify the talent of craftsmen who show ingenuity by creating innovative and quality works.

Among these prizes is the prize for the creativity competition which was instituted to reward the most creative African craftsmen.

Article 1 : Objectives of the contest

The objectives of the creativity contest are:

- stimulate craftsmen to create new quality works;
- ✓ give visibility to innovative works;
- recognize the talent and ingenuity of creators;
- encourage the participation of talented craftsmen at the exhibition

Article 2: Terms of participation

The creativity contest is open to individual craftsman and / or associations or groups of African's craftsmen.

All the applications for the creativity contest must first be preselected at national level, which works are pre-selected by the competent structures of the Ministry in charge of the country's craft industry. Each candidate may present a maximum of three [03] works of which he is actually the creator. These works should not be replicated but new creations. Each candidate fills out a registration form for each work he presents.

Every application is only admissible when the following documents are provided by the candidate:

- ✓ Stand payment receipt
- A photocopy of the craftsman's professional card or a letter of recommendation from the Ministry in charge of crafts or from the professional organization to which the craftsman belongs to:
- A high-definition photo of the work in printed and digital version;
- ✓ The craftsman business card
- the craftsman's bank account statement (if necessary)
- A technical sheet of the work in one page maximum.

Article 3 : Selection Criteria

For each type of product, the preselection criteria are the following:

- · compliance with the theme of the edition,
- accessibility to the international market,
- originality, design and aesthetics,
- · imnovative,
- series production capacity,
- functionality,
- Cultural content.

Article 4 : The international jury

The international jury of the creativity contest is the same as the one that awards the "Great Prize" of H.E. the President of Faso. Members are renowned for their knowledge in the fields of craftsmanship, design and/or product marketing. The choice of the president and the members of the international jury is left to the discretion of the General Commission of the exhibition. The jury elaborates and adopts its own working methodology. This methodology is made available to the SIAO from the start of the jury's work and can be published if necessary.

The jury of the creativity contest draws up a report signed by the members of the jury which is submitted in a sealed envelope to the competent section of the General Commissariat of the Exhibition. The said report is provided in three (03) copies in paper format and in electronic file.

The renumeration of the international jury of the creativity competition is done in accordance with the joint decree n * 2019-0138 / MINEFID / MCIA of April 12, 2019 covering the payment of specific services within the framework of the organization of SIAO editions and of SARA.

Article 5: Awarding of prizes and announcement of results. The Creativity Prize rewards the three best works in the Creativity Pavilion;

It is composed of three lots namely:
- First prize : 2.500,000 F CFA
- Second prize : 1 750 000 francs
- Third prize : 1 250 000 francs CFA

The proclamation of the results takes place on the 8th day of the exhibition and the awards ceremony, no later than 48 hours after the closing of the show.

Article 6: Miscellaneous

6.1. The destination and exploitation of the works exhibited at the Pavilion of Creativity

The exhibitor waives all claims, both against the General Commissariat of the exhibition and the producers or distributors, because of the broadcasting, for the purposes of the event, in Burkina Faso and abroad, by television, videogram or any other medium (books, booklets), his image, that of his work, his brand, his staff, his products or services. He undertakes to impose this obligation on his staff, his subcontractors and his co-contractors.

However, any natural or legal person other than the CGS and the accredited media wishing to shoot must first have the agreement of the exhibitor and the General Commissariat of the exhibition.

- 6.2. Any unselected or non-winning work is returned to his/her author without compensation of any kind.
- 6.3. Award-winning works become the property of SIAO
 6.4. Any dispute arising from the application or interpretation
 of this Regulation will be settled friendly and by default by the
 competent courts of the organizer's headquarter.
